## JOIN THE NETWORK

Dundee Social Enterprise Network is a membership organisation whose strength lies in being firmly focused on providing support to Social Enterprises and aspiring Social Entrepreneurs based or working in Dundee. Membership of the Network is also open to Social Enterprises in the surrounding area and all Public and Private sector organisations with an interest in Social Enterprise. Our Management Committee is drawn from leaders in the Social Enterprise sector and is advised by specialist staff with a wide range of skill and expertise. The membership year runs from the 1 April to the following 31 March.

## MEMBERSHIP CATEGORIES

There are four categories of membership. Please check below to see which category is relevant to your organisation, the available benefits and the costs of membership. All memberships are reviewed annually.

### A FULL MEMBERSHIP

Level 1 - 0 – 5 staff £50  
 Level 2 - 6 – 15 staff £80  
 Level 3 - Over 15 Staff £120

#### To meet the requirements of full membership:

- Your organisation will be a Social Enterprise operating in Dundee,
- Your organisation will adhere to the 'Voluntary Code of Practice for Social Enterprise in Scotland'.
- Your governing document will demonstrate that there is an 'asset lock'.
- You organisation will be a: *Company Limited by Guarantee, Community Interest Company, Registered Charity, SCIO, Cooperative and Community Benefit Society, or Trust.*
- Your organisation will be trading.

### B ASPIRING MEMBERSHIP (£20 per year)

#### To meet the requirements of aspiring membership:

- Your organisation may not currently meet the criteria for Full Membership but should be actively working towards doing so.

### C ASSOCIATE MEMBERSHIP (£100 per year)

#### To meet the requirements of associate membership:

- Your organisation will be a Social Enterprise operating out with Dundee, a Registered Charity with limited trading, a Voluntary Organisation, or an Educational Establishment.

## D CORPORATE MEMBERSHIP (Package by agreement)

#### To meet the requirements of corporate membership:

- Your organisation will be a Public Sector Body, Private Sector Company, or a Professional Consultancy Service.
